QUESTIONS FROM THE VIDEO

- 1. What Spanish explorer sailed the Pacific Ocean in 1774?
 - Answer: Juan Perez
- 2. What areas did he claim for Spain?
 - Answer: The Pacific Northwest Oregon, Washington and British Columbia
- 3. How can one claim land that people have lived on for thousands of years?
 - Answer: You can't, it was stolen land
- 4. What disease did the Europeans introduce to the First People of this land?
 - Answer: smallpox
- 5. What did this disease do to the First People of this land?
 - Answer: They were ravaged by smallpox and it annihilated most of the people
- 6. Before European contact, how did the First People of this land live healthy lives?
 - Answer: They understood the land, they stayed healthy, they didn't ruin and destroy things, they followed the rules of the land and the earth took care of them
- 7. In 1790, what was signed by Spain that allowed others to come to the Pacific Northwest to exploit the land and take what was not theirs?
 - Answer: The Nootka Concession
- 8. What did George Vancouver do and see when he arrived in the Puget Sound in 1792?
 - Answer: Made the first map of Puget Sound. He saw the marks of smallpox on the faces of the First People
- 9. In 1818, what did the United States and Great Britain argue over?
 - Answer: They argued over who would exploit 'Oregon Country'
- 10. In 1819, Spain ceded stolen land to whom?
 - Answer: The United States
- 11. What two things did fur traders exploit upon their arrival in 1824?
 - Answer: They exploited the First People of this land to be able to exploit animal furs

- 12. What animals did the fur traders decimate and annihilate on this land?
 - Answer: Mink, Fisher, Weasel, Marmot and Raccoons
- 13. In 1827, what happened at Fort Langley?
 - Answer: Europeans set up trade with the First People for food and clothes
- 14. What fort did Hudson Bay Company set up in the Puget Sound?
 - Answer: Fort Nisqually
- 15. What do the First People call the Europeans and why?
 - Answer: The First People call people with European dissent "pastad" because Caucasians came here from Boston, on the East Coast
- 16. Who were the first two men from the East Coast to build the first European homes in this area during 1854?
 - Answer: Michael T. Simmons Caucasian, and George Washington Bush Black
- 17. What happened on this land in 1848?
 - Answer: The United States Oregon Territory was created to include Oregon and Washington
- 18. When was Washington Territory established?
 - Answer: 1853
- 19. What happened on this land in 1854?
 - Answer: The Medicine Creek Treaty was created and the First People relinquished 2.5 million acres, as the Caucasian promised to provide the First People of this land reservations. This treaty promised the First People that they could hunt and fish in their usual accustomed areas
- 20. What happened on this land between 1855-1856?
 - Answer: The First People and Caucasians had a war
- 21. When did Washington Territory become the 42nd state of the United States?
 - Answer: 1889

Please envision this explain how you would feel.
